This is to guarantee the described puppy to be free of disease or other health defects other than common puppy maladies at time and date of receipt.

Please allow forty-eight (48) hours for the puppy to acclimate to its new environment. The Purchaser is responsible for taking the puppy to a duly qualified and registered veterinarian by the end of business on the fourth (4) day for a complete examination. The purchaser is responsible for all veterinarian expenses. If the buyer chooses not to take said puppy to the vet for an exam within the allocated time period, he or she forfeits all rights to a guarantee on purchased dog/puppy. A copy of the examination must be sent to the seller, DeMi Poms, within four (4) days of the examination. If the veterinarian finds anything seriously wrong with the puppy other than a common puppy malady, it will be exchanged for another puppy of equal value, providing a letter from the examining veterinarian is offered as evidence of the puppy's illness. I, the seller, must receive

this letter within 24 hours after the exam has taken place. If I do not receive the letter within the 24 hour period no exchange will be made. If puppy is returned I, the seller, will refund the purchase price of puppy and pay for return shipping, but the initial shipping cost is nonrefundable. Purchaser must return the puppy prior the expiration of the initial health certificate (health certificate is valid for 10 days only). I, the seller, reserve the right to get a second opinion from a duly qualified and licensed veterinarian. If no puppy is available then I will refund the purchased price of the puppy.

Great care is exercised to prevent or eliminate parasites such as worms (roundworms, hook worms, tapeworms, coccidian) fleas, ear mites, and ring worms, however, since these are quite common among animals we can not guarantee any animal to be a totally parasite free. Care has been taken to give puppies their first round of shots and worming, it is the buyer's responsibility to see the ongoing of shots, worming and love.

If ever you, the purchaser, become unable to care for the said puppy/dog at anytime during its lifetime, we, the seller, would like to be notified and given first right of refusal.

It is further understood and agreed that no warranty or representation has been made with respect to the sold puppy, except set forth in writing in this agreement.
